## **SUPERINTENDENT SEARCH**

The Board approved the list of names for the confidential Stakeholder Group. The Stakeholder Group and the Board will interview the Semi Finalist candidates in separate confidential interviews on April 3-5, 2019.

The Board will meet on April 6 in Executive Session to determine the finalist candidate. The Board may do a site visit to the finalist candidate district during the week of April 7-12.

The Board anticipates an announcement of the selection of the permanent superintendent during the Regular Board Meeting on Monday, April 22.
