Dear Parents and Guardians,

The State of Oregon has received approval from the federal government to issue Pandemic EBT (P-EBT) for the 2020 - 2021 school year.

HOW DOES MY STUDENT QUALIFY FOR P-EBT BENEFITS?

Have an approved Free and Reduced Meal application on file for the 20.21 school year.

I AM NOT SURE, OR I CAN'T REMEMBER, IF I HAVE AN APPROVED FREE AND REDUCED MEAL APPLICATION ON FILE:

Before filling out another application, please call Lonna Capaci at Nutrition Services at 541.967.4622 or email lonna.capaci@albany.k12.or.us to verify if you already have an approved application on file.

MY STUDENT ALREADY RECEIVES SNAP BENEFITS, WHAT DO I NEED TO DO?

You do not need to fill out a Free and Reduced Meal application.

Students who are already receiving Supplemental Nutrition Assistance Program (SNAP) benefits will receive the P-EBT benefits on the EBT card associated with their household's SNAP case.

MY STUDENT ATTENDS A CEP SCHOOL:

You do not need to fill out a Free and Reduced Meal application. Your student is automatically qualified to receive Free and Reduced Meals. *However, if you have a student attending a non- CEP school living in the same household as the student attending a CEP school, you will need to fill out an application for that student.* (See below for a list of CEP schools).

HOW WILL I RECEIVE P-EBT BENEFITS?

Each student will receive their own P-EBT card. Students and households new to P-EBT and households with more than one student will receive an Oregon P-EBT card in the mail with instructions. Cards will be mailed to the address on file with the school for those students who do not receive SNAP. *If your mailing address has changed during the school year, please call your school and update your address.*

WHEN WILL WE RECEIVE THE BENEFITS?

Oregon plans to start sending them out in July of 2021.
